Participant shall purchase either offline or online one (1) of the following Logitech mouse: M350 Pebble mouse or K380 Multi Device Bluetooth keyboard or MK470 Slim Wireless Combo ("Qualifying Device") solely from the Participating Retailers (additional terms and conditions apply) during the Promotion Period as defined below to participate in the Offer and shall register during the Promotion Period via https://www.logitech-promotions.com/ and A) enter i) its Receipt (uploading digital Receipt or an image of its Receipt) and ii) the required information (First name, last name, address, telephone number, email address) and B) answer the following question "Why are you the best person to win custom sneakers" ("Entry").
