How long do we keep your data?

- Identification data: at least 5 years after the end of the agreement
- Location data: up to 1 year after the end of the agreement
- Website statistics and behavioral data: 26 months

10XCREW does not sell your data to third parties and only provides it if necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a contract with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. 10XCREW remains responsible for these processing operations.

## COOKIES

Cookies are text files that are stored on your computer or mobile device when you visit the website. 10XCREW uses cookies with a purely functional functionality.
